Govt land worth Rs 5 cr freed of encroachment

Jabalpur: The Jabalpur district administration in Madhya Pradesh on Tuesday removed encroachments on around 23.26 sq km of government land with a market value of Rs 5 crore located opposite the main office of the city civic body as an official said.

Additional Collector Namish Shrivastava said the encroachments included illegally constructed shops, a motorcycle workshop, a resale car market, and a tea stall located on the government land near Nidhiya Garden, Nidhiya Garden. A portion of this government land was encroached upon by one Wasim Pathan against whom cases of attempt to murder and obstructing a public servant from carrying duties are registered as the local police station, Arjuna said, adding that Wasim had helped his brother Abhishek Rajak in the construction of a shop.
