Re: Show Cause Notice for declaring Mrs. Gupta & Sons (Motors) Pvt. Ltd. and its Director/Guarantors as Willful Defaulters and for appointment for Representation there against.

We refer to your captioned account and wish to inform you that due to non-payment of interest/instalment, account turned to Non-Performing Assets in the books of the Bank on 28.08.2019.

We further wish to inform you that as per the directions of the Committee of Executives on Willful Defaulters of our Bank and on scrutiny of your account based on your acts of omission and commission, deeds and documents and writings, performed/executed by the company/director/guarantors, the company/firm and its Director/Guarantors classified as Willful Defaulter as per guidelines of RBI on the following grounds:

- The borrowers have defaulted in meeting its payment/repayment obligations to the lender even though have the capacity to honour the said obligations.
- The present outstanding in the cash credit account is Rs. 7.18 Cr against the sanctioned limit of Rs. 6.00 Cr.
- As per the statement of account huge inter firm transfer of funds made by the company Cash Credit account 1 to its associate lender concern. Some of the transferred fund includes:
  - Fund Transferred from cash credit account to Mrs Gupta & Sons in Yes Bank Ltd. Rs. 6.50 Lac.
  - Fund Transferred from cash credit account to Overdraft account of Mrs Gupta and Sons
- Borrower Company has made multiple unrelated transaction outside business with its SG & S.
- As per the stock statement on December 2019, stocks of Rs. 2.25 Cr were available with the firm. As per the Stock Audit report dated 14.02.2020, the firm was having Stocks of Rs. 0.08 Cr only at the unit. Stock has been sold out and proceeding of sold stock is not deposited in cash credit account.

Thus the company has defaulted in meeting its payment/repayment obligations to the lender, even when they have the capacity to honour the same and has ignored/diverted the funds so that the funds have neither been utilized for the specific purpose for which finance was availed, nor are the funds available with the firm/company in the form of other assets.

In terms of RBI guidelines and to comply principles of natural justice, if you desire, you may send your submission for consideration by the Committee of Executives, headed by our Executive Director within 15 days from the date of receipt of this letter as to why you're account and you are not classified by Bank as a Willful Defaulter. The Committee reserves the right to give or not to give the personal hearing to decide about classifying as willful defaulter in case your submission is received.

Please note that, in case your submission against the intention of Bank to declare you as a Willful Defaulter is not received within -15- days from the date of receipt of this letter, the Bank will proceed further and classify your account as willful defaulter. Bank reserves the right to publish the name and photograph of Willful Defaulter in News Paper and will initiate the necessary recovery action as per extant guidelines issued by Reserve Bank of India.
